A public meeting was held on the subdivided property belonging to Our Lady of the Lake. Our Lady of the Lake has brought all the various lots into one big lot and divided out two lots to donate to the Town of Walker for water and sewer.

A public meeting was held for the new development of Cobblestone, a 31 unit town home development located at 11705 Burgess Avenue for Mr. John Blount. Mr. Billy Taylor with McLin and Associates was present to offer information on the development. Two buildings will be built to start off with and more will be built at a later time, at which time the road will be completed for the whole development. The house on the property will be torn down along with the construction of the town homes. The fire department has looked at the construction documents on the development to assure the adequate access of emergency vehicles.

A motion was made by Mr. Travis, seconded by Mr. McNemar, to approve the development of the eight (8) buildings, which will consist of 31 units, once completed.

A public meeting was held on the rezoning of lot 1-A-2 from RPG to C-1 for Mr. Cliff Marsh located at 30130 Mayer Street. The Town of Walker has placed some restrictions on the rezoning of the location if it is approved. After some discussion, the Commission wanted to add one stipulation to the list of restriction made by the Town of Walker. The added restriction included the leasing of the property. The restrictions are:

- That Tract 1-A-2 and all improvements situated thereupon will be used ONLY as a home based Heating and Air Conditioning Installation business known as Marsh Heating and Air. Mr. Marsh's home will be built on Tract 1-A-1.
- No retail sales of air conditioning and heating equipment and supplies will be allowed on Tract 1-A-2.
- No manufacturing of heating and air conditioning equipment and supplies will be allowed on Tract 1-A-2.
- Pickup trucks will be used in the home based Heating and Air Conditioning Installation business.
- No trucks larger than pickup trucks will be used to deliver heating and air conditioning supplies to Tract 1-A-2.
- Cliff Marsh will erect a fence as set forth in Walker Code of Ordinances Section 20-63 between Tract 1-A-2 and the residential property adjacent to Tract 1-A-2 to the west along boundary line N 08° 04' 00" west measuring 292.07.
- If Cliff Marsh sells and/or leases either Tract 1-A-1 or 1-A-2 then the C-1 zoning for Tract 1-A-2 will revert back to RPG zoning. If Cliff Marsh sells and/or leases Marsh Heating and Air then the C-1 zoning for Tract 1-A-2 will revert back to RPG zoning.

A motion was made by Mr. Granger, seconded by Mr. McNemar, to recommend to the Board of Aldermen, the approval of the request, with the addition of the stipulation concerning the selling or *leasing* of the properties.
